

THE APPROPRIATION (1969/70) ACT, 1969

AN ACT TO AUTHORISE THE PAYMENT OUT OF THE CONSOLIDATED FUND AND THE DEVELOPMENT FUND OF SUMS OF MONEY FOR THE YEAR ENDING ON THE 31ST MARCH, 1970.

Date of Assent: 31.3.69.

Date of Commencement: 1.4.69.

ENACTED by the Parliament of Botswana.

Short Title

1. This Act may be cited as the Appropriation (1969/70) Act, 1969.

Expenditure of R11,908,490 from Consolidated Fund

2. The Minister of Finance may issue a warrant for the payment out of the Consolidated Fund for the year ending on the 31st March, 1970, of the sum of Eleven million nine hundred and eight thousand four hundred and ninety rand.

Appropriation Thereof

3. The sum authorised by section 2 is appropriated to and shall be applied for the purposes of the heads of expenditure set out in the first and second columns of the First Schedule, in the amounts set opposite thereto in the third column of that Schedule.

Expenditure of R7,622,272 from Development Fund

4. The Minister of Finance may issue a warrant for the payment out of the Development Fund for the year ending on the 31st March, 1970, of the sum of Seven million six hundred and twenty-two thousand two hundred and seventy-two rand.

Appropriation Thereof

5. The sum authorised by section 4 is appropriated to and shall be applied for the purposes of the heads of expenditure set out in the first and second columns of the Second Schedule, in the amounts set opposite thereto in the third column of that Schedule.
