IN EXERCISE of the powers conferred by section 25 of the Precious and Semi-Precious Stones (Protection) Act, the following Regulations are hereby made –

Citation 1. These Regulations may be cited as the Jwaneng Precious Stone Protection Areas (Amendment) Regulations, 1979.

Amendment of regulation 5 of S.I. 60 of 1979 2. Regulation 5 of the Jwaneng Precious Stone Protection Areas Regulations, 1979, is amended by inserting therein immediately after subregulation (2) thereof, the new subregulation following –

“(3) A householder permit issued under subregulation (1) shall be for such period as the lawful authority may determine and such permit may be issued subject to such terms and conditions as the lawful authority may in each case determine.”.

Amendment of First Schedule to S.I. 60 of 1979 3. The Jwaneng Precious Stone Protection Areas Regulations, 1979, are amended by substituting for the First Schedule thereto the new Schedule following –
