IN EXERCISE of the powers conferred on the Minister of Finance and Development Planning by section 8 of the Military Pensions Special Fund Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Military Pensions Special Fund (Amendment) Regulations, 1979, and shall be deemed to have come into operation on 1st April, 1978. Citation and commencement
2. The proviso to regulation 10 (1) of the Military Pensions Special Fund Regulations (hereinafter referred to as "the principal Regulations"), is amended — Amendment Cap. 27:06 (Sub. Leg.)
  - (a) in paragraph (a) thereof —
    - (i) by substituting for the words "P143,37", which appear in subparagraph (i) (a), the words "P164,88"; and
    - (ii) by substituting for the words "P190,22", which appear in subparagraph (i) (b), the words "P218,75"; and
  - (b) in paragraph (iv) thereof, by substituting for the words "P13,70", which appear therein, the words "P15,76".
3. Regulation 14 of the principal Regulations is amended by substituting for the words "P4,95" and "P6,60", which appear therein, the words "P5,69" and "P7,59" respectively. Amendment of regulation 14 of principal regulations
4. Regulation 16 of the principal Regulations is amended — Amendment of regulation 16 of principal Regulations
  - (a) in subregulation (1) thereof, by substituting for the words "P91,88", which appear in the proviso thereto, the words "P105,66"; and
  - (b) in subregulation (2) thereof, by substituting for the words "P169,26", which appear in paragraph (a) of the proviso thereto, the words "P194,65".
5. Regulation 17 (1) of the principal Regulations is amended by substituting for the words "P82,55", which appear therein, the words "P94,93". Amendment of regulation 17 of principal Regulations
