An Act to amend the Small Lotteries Act

Date of Assent: 9.9.80.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Small Lotteries (Amendment) Act, 1980. Short title

2. The Small Lotteries Act (hereinafter referred to as "the principal Act") is hereby amended by substituting for section 2 thereof the following new section — Amendment

Inter-pretation 2. In this Act, unless the context otherwise requires, "Registrar" has the meaning assigned to it in the Societies Act."

Cap. 18:01

3. The principal Act is hereby amended by substituting for section 3 thereof the following new section —

"Small lotteries deemed lawful 3. A lottery shall be deemed to be lawful if it is promoted on behalf of a society registered under the Societies Act and is promoted and conducted in accordance with the provisions of section 6."

Deletion of sections 4 and 5 of principal Act

4. The principal Act is hereby amended by deleting sections 4 and 5 thereof.

Amendment of section 6 of principal Act

5. Section 6 (1) of the principal Act is hereby amended —
(a) by substituting for the words “P2 000”, which appear in paragraph (c) thereof, the words “P8 000”;
(b) by deleting the words “, being purposes described in section 4 (a), (b) or (c)”, which appear in paragraph (d) thereof; and
(c) by substituting for the words “P2 500”, wherever they appear in paragraph (g) thereof, the words “P10 000”.

Amendment of section 8 of principal Act

6. Section 8 of the principal Act is hereby amended —
(a) in subsection (1) thereof, by substituting for the words “District Commissioner in whose district the society is registered in terms of section 5”, which appear therein, the word “Registrar”; and
(b) in subsection (2) thereof, by substituting for the words “The District Commissioner to whom any return is sent under this section shall preserve the return”, which appear therein, the words “The Registrar shall preserve any return made under subsection (1)”.

Saving

7. Notwithstanding the amendment of section 3 of the principal Act, any society registered under that section immediately prior to the commencement of this Act shall be deemed to have been registered under the Societies Act.
