IN EXERCISE of the powers conferred on the President by section 11 (5) of the Customary Courts Act, the following Order is hereby made:-

1. This Order may be cited as the Customary Courts (Increase of Criminal Jurisdiction) Order, 1983.

2. The jurisdiction in criminal matters of each of the customary courts specified in the first column of the First Schedule hereto, under the district within which it has been recognised or established and within the area specified in the corresponding entry in the second column hereto, shall be that indicated by letters in the corresponding entry in the third column of the said Schedule, which letters refer to the maximum fines or sentences of imprisonment which may be imposed by the court and which are more fully indicated in the Second Schedule hereto.
