IN EXERCISE of the powers conferred on the Minister of Commerce and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made —

| <p>3. No person shall sell by retail, either in person or through an agent or employee, —</p> <p>(a) at any place specified in the first column of the Schedule, the petroleum product specified at the head of the second, third, fourth, or fifth column of the said Schedule at a price exceeding the amount per litre specified in relation to that place in that column which amount includes —</p> <p>(i) levies of 1,90 thebe and 2 thebe per litre payable in respect of the Equalization Fund and the National Petroleum Fund respectively in respect of petrol,</p> <p>(ii) the levy of 3,90 thebe per litre payable in respect of the Equalization Fund in respect of low rate, middle rate and high rate diesel, and 1 thebe per litre payable in respect of the National Petroleum Fund in respect of middle rate diesel,</p> <p>(iii) the levy of 5 thebe per litre payable in respect of the National Petroleum Fund in respect of high rate diesel;</p> <p>(b) at any place specified in the first column of the said Schedule, illuminating paraffin for domestic use in quantities of a litre or less at a price proportionate to that specified in relation to that place in the third column of the said Schedule; or</p> <p>(c) at any place not specified in the first column of the Schedule, the petroleum product specified at the head of the —</p> <p>(i) second column of the Schedule at a price exceeding by more than 6,00 thebe,</p> | <p>Retail prices of petroleum products</p>                    |

- (ii) third column of the Schedule at a price exceeding by more than 6,00 thebe,  
 (iii) third, fourth or fifth column of the Schedule at a price exceeding by more than 6 thebe, per litre the price at which the product was delivered to him.
