

**An Act to amend the Judges (Miscellaneous Provisions) Act**

*Date of Commencement:* 1.4.88.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the Judges (Miscellaneous Provisions) (Amendment) Act, 1988.

come into operation on 1st April, 1988.

2. Section 3 of the Judges (Miscellaneous Provisions) Act (hereinafter referred to as "the principal Act") is hereby amended —

(a) in subsection (1) thereof by substituting for the words "P3 354" which appear therein, the words "P3 588" and

(b) in subsection (2) thereof by substituting —

(i) for the words "P295" which appear in paragraph (a) therein, the words "P316";

(ii) for the words "P737" which appear in paragraph (b) therein, the words "P789";

(iii) for the words "P29,70" which appear in paragraph (c) therein, the words "P31,78".

3. Section 4 of the principal Act is hereby amended —

(a) in paragraph (a) thereof by substituting for the words "P38 052" which appear therein, the words "at the rate of P41 340 per annum for February and March, 1988, and thereafter P44 232";

(b) in paragraph (d) thereof by substituting for the words "P888" which appear therein, the words "P951".

4. Paragraph (a) of section 5 of the principal Act is hereby amended by substituting for the words "P31 452" which appear therein, the words "at the rate of P35 532 per annum for February and March, 1988, and thereafter P38 016".

5. The principal Act is hereby amended by the addition after section 5 thereof of the following new section as section 5A —  
"5A Notwithstanding the provisions of sections 4 and 5, the President may authorise the payment of an allowance in excess of the allowances set out in those sections to a High Court Judge."
