1. Short title and commencement
2. Amendment of paragraph 4 of Schedule to Act No. 3 of 1992

An Act to amend the National Assembly (Salaries and Allowances) Act, 1992

Date of Assent: 29.11.94.

Date of Commencement: 15.10.94.

ENACTED by the Parliament of Botswana.

1. This Act may be cited as the National Assembly (Salaries and Allowances) (Amendment) Act, 1994, and shall be deemed to have come into operation on 15th October, 1994.

(b) for a Member representing one of the following constituencies —

- at the rate of P16 032 per annum;
- (c) for a Member representing one of the following constituencies —
- Nkange
 - Mmadinare
 - Tswapong North
 - Tonota
 - Tswapong South
 - Palapye
 - Mahalapye
 - Kgatleng East
 - Kgatleng West
 - Thamaga
 - Moshupa
 - Ngwaketse South
 - Serowe South
- at the rate of P21 036 per annum;
- (d) for a Member representing one of the following constituencies —
- Serowe North
 - Sebina and Gweta
 - North East
 - Shoshong
 - Bobirwa
 - Barolong
 - Lentsweletau
- at the rate of P23 040 per annum;
- (e) for a Member representing one of the following constituencies —
- Ngami
 - Ghanzi
 - Boteti
 - Maun and Chobe
 - Letlhakeng
 - Ngwaketse West
- at the rate of P25 776 per annum;
- (f) for a Member representing one of the following constituencies —
- Okavango
 - Kgalagadi
- at the rate of P29 352 per annum.
