IN EXERCISE of the powers conferred on the Minister of Trade and Industry by section 3 of the Control of Goods, Prices and Other Charges Act, the following Regulations are hereby made—

1. These Regulations may be cited as the Control of Goods, Prices and Other Charges (Petroleum Prices) (Amendment) (No. 2) Regulations, 2003, and shall come into force on 1st July, 2003. Citation and commencement

2. The Control of Goods, Prices and Other Charges (Petroleum Prices) Regulations are hereby amended by substituting, for the Schedule thereto, the following new Schedule — Amendment of Cap.43:07 (Sub. Leg)
