IN EXERCISE of the powers conferred on the Minister of Labour and Home Affairs by section 34 of the Immigration Act, the following regulations are hereby made —

1. These Regulations may be cited as the Immigration (Amendment) Regulations, 2004. Citation
2. The Regulations are hereby amended by inserting, immediately after regulation 14 thereof the following new regulation — Insertion of Regulation 14A in the Regulations
 - “14A(1) An application for authority to remain in Botswana for more than 90 days, in terms of the proviso to section 17(1) of the Act, shall, if made prior to the expiration of 90 days, be accompanied by a fee of P25.
 - 14A(2) An application for authority to remain in Botswana for more than 90 days, in terms of the proviso to section 17(1) of the Act, shall, if made after the expiration of 90 days, be accompanied by a fee of P100.
3. Regulation 16 is amended— Amendment of Regulation 16
 - (a) by inserting immediately after subregulation (1) thereof, the following new subregulations —
 - “16(1A) Where a spouse and children are included in an application for residence permit, the fee payable shall be P25 each in respect of a spouse and each child.
 - 16(1B) In respect of changing conditions of a permit, the fee payable shall be P150.”
 - (b) in subregulation (1) thereof, by substituting, for the words “P80”, the words “P500”; and
 - (c) in subregulation (2) thereof, by substituting, for the words “P50”, the words “P250”.
4. Regulation 17 is amended — Amendment of Regulation 17
 - (a) in subregulation (1) thereof, by substituting, for the words “P30”, the words “P200”; and
 - (b) in subregulation (2) thereof, by substituting, for the words “P60”, the words “P200”.

5. Regulation 19 is amended in subregulation (1) thereof, by substituting, for the words "P100", the words "P500".
6. Regulation 21 is amended by substituting, for the words "P1", the words "P20".
7. Form 15, which follows Form 13 in chronological order, is amended by substituting for the heading thereof, the following new heading —
