ARRANGEMENT OF REGULATIONS

REGULATION

1. Citation and Commencement
2. Amendment of First Schedule Cap. 69:01 ( Sub. Leg)

IN EXERCISE of the powers conferred on the Minister of Works and Transport by section 130 of the Road Traffic Act, the following Regulations are hereby made —

- Citation and Commencement      1. These Regulations may be cited as the Road Traffic (Amendment) Regulations, 2004 and shall come into operation on the 1st March, 2004.
- Amendment of First Schedule Cap. 69:01 (Sub. Leg.)      2. The Road Traffic Regulations are amended by substituting for the First Schedule thereto, the following new Schedule —
