IN EXERCISE of the powers conferred on the Law Revision Commissioner by section 5 (2) of the Revision of the Laws Act, this Order is hereby made —

1. This Order may be cited as the Law Revision Order, 2008. Citation
2. As and from 31st December, 2007, the pages specified in the third column of the First Schedule of the enactments specified in the first and second columns of the said Schedule are authorised for inclusion in and shall form part of the Laws of Botswana. Authority for inclusion of pages in Laws of Botswana
3. As and from 31st December, 2007 — Authority for removal and inclusion of certain pages in Laws of Botswana
 - (a) the pages specified in the third column of the Second Schedule of the enactments specified in the first and second column of the said Schedule are authorised to be removed from the Laws of Botswana; and
 - (b) the pages specified in the third column of the Third Schedule of the enactments specified in the first and second columns of the said Schedule are authorised to be included in the Laws of Botswana.
4. The enactments referred to in paragraphs 2 and 3 (b) represent the respective Laws in force on 1st January, 2008. Effective date of Laws
5. Law Revision Order, 2007, is hereby revoked. Revocation of S.I. No. 46 of 2007
