ARRANGEMENT OF REGULATIONS

REGULATION

1. Citation
2. Exemption from regulation 5 (1) (b) of Cap. 43:11 (Sub. Leg.)

IN EXERCISE of the powers conferred on the Minister of Investment, Trade and Industry by section 38 as read with section 42 (2) (g) of the Liquor Act, the following Regulations are hereby made –

Citation **1.** These Regulations may be cited as the Liquor (Exemption) (No. 14) Regulations, 2016.

Exemption from regulation 5 (1) (b) of Cap. 43:11 (Sub. Leg.) **2.** ZCX Investment (Pty) Ltd, trading as Liquorama Bottle store, is exempt from the provisions of regulation 5 (1) (b) of the Liquor Regulations, which provide that bottle store liquor licences shall be reserved for citizens of Botswana or to companies wholly owned by citizens of Botswana, for the following bottle stores –
