IN EXERCISE of the powers conferred on the Minister of Investment, Trade and Industry by section 42 of the Liquor Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Liquor (Amendment) Regulations, 2018. Citation

2. The Liquor Regulations (hereinafter referred to as “the Regulations”) are amended in regulation 2, by substituting for subregulation (1) the following new subregulation — Amendment of regulation 2 of Cap. 43:11 (Sub. Leg.)

“(1) An application for a licence under section 13 (1) of the Act, shall be in Form 1 or Form 1A as set out in the Third Schedule.”.

3. The Third Schedule to the Regulations is amended by inserting immediately after Form 1, the following new Form 1A — Amendment of Third Schedule to the Regulations

1. Letter of authority to represent the company
2. Certified copies of certificate of registration (for registered business names) or certified copies of certificate of incorporation and annual return forms (for registered companies)
3. Certified copies of identity documents/passports of listed company shareholders/equity directors
4. Physical planning report
5. Environmental health report
6. Fire report
7. Letter of consent by the owner of the premises.”.
