IN EXERCISE of the powers conferred on the Minister by section 5 as read with section 3 of the Local Government Act, the following Order is hereby made —

1. This Order may be cited as the Local Government (Establishment of Hukuntsi District Council) Order, 2022. Citation

2. (1) There shall be a district council, to be known as the Hukuntsi District Council (hereinafter referred to as “the Council”), in respect of the area defined in Schedule 1. Constitution and establishment of Hukuntsi District Council

(2) The Council shall consist of —

- (a) eight elected members;
- (b) two nominated members; and
- (c) *ex-officio* members being —
  - (i) an administrative officer who has special responsibilities relating to the development of the area,
  - (ii) every land board chairperson within the Administrative District,
  - (iii) every member of the *Ntlo ya Dikgosi* designated or selected under subsection (1) or (2) of section 78 of the Constitution, and
  - (iv) a *Kgosi* who resides within the headquarters of the Council.

(3) An elected member of the Council shall be elected at each polling district within the Council area in the manner provided by the Electoral Act. Cap. 02:09

(4) A nominated member of the Council shall be appointed by the Minister in writing.

(5) For the purposes of this Order “polling district” means a polling district established under the Electoral Act.

3. A person shall not be disqualified from being a member of the Council because he has applied for and has been granted a passport issued by or under the authority of the Government of any of the countries specified in Schedule 2. Persons not disqualified for membership of Council

4. Where a seat of a member of the Council becomes vacant by virtue of any of the provisions of the Act, the vacancy shall be filled in accordance with the provisions of paragraph 2. Filling of vacancy

Functions of  
Council

5. The Council shall perform the functions set out in Schedule 1 to the Act, and any function delegated by the Minister.
