IN EXERCISE of the powers conferred on the President by section 2 of the Administrative Districts Act, the following Order is hereby made —

Citation and commencement **1.** This Order may be cited as the Declaration of Administrative Districts (Amendment) (No. 2) Order, 2022 and shall come into operation on 1st April, 2023.

Amendment of Schedule to Cap. 03:02 (Sub. Leg.) **2.** The Order is amended by substituting, for the Schedule thereto, the following new Schedule —

North-East

The area known as the Tati District and the Gungwe State Lands and of which the boundary runs from the junction of the Ramokgwebana River with the Shashe River along the Ramokgwebana River to its source; thence by the watershed of the rivers Shashe and Ramokgwebana until that watershed strikes the old Hunter’s Road (called the Pandamatenga Road); thence by that road to the place where it first crosses the Shashe River; thence along that river to its junction with the Ramokgwebana River:

Provided, however, that there shall be excluded from the said area the area of Francistown the boundaries of which are as hereunder described.
