**PUBLIC ROADS (GRANT OF WAYS OF NECESSITY) ORDER, 2023**  
(Published on 14th April, 2023)

ARRANGEMENT OF PARAGRAPHS

PARAGRAPH

1. Citation
2. Grant of ways of necessity

IN EXERCISE of the powers conferred on the Minister of Transport and Public Works by section 4 of the Public Roads Act, the following Order is hereby made --

1. This Order may be cited as the Public Roads (Grant of Ways of Necessity) Order, 2023. Citation

2. (1) The ways of roads of necessity described in the Schedule hereto are granted as ways or roads of necessity. Grant of ways of necessity

(2) The width and direction of each way or road of necessity under subparagraph (1) shall be as it appears in the drawings deposited by the applicants with the Director of Surveys and Lands.

SCHEDULE

The Minister grants authority to --

- (a) Humphery David & Partners (Pty) Ltd for all movement at grade intersection with bituminous surfacing, turning and auxiliary lanes with sufficient drainage facility of the road along A12 road for proposed development in Molepolole as per drawing No. ST 2201/S100/C Rev C by Sethiba Kgalaeng;
- (b) A-Villa Engineering (Pty) Ltd for a proposed road reserve occupation by 1 No. Underground crossing and 5km overhead 33kv power line along A3 road in Dukwi as per drawing No. 001, Rev A by Botswana Power Corporation;
- (c) Theo le Theetso Consulting Civil Engineers (Pty) Ltd for all movement at grade intersection with bituminous surfacing, turning and auxiliary lanes with sufficient drainage facility of the road along A1 road for proposed development in Palapye as per drawing No. CIV/2021/3004 Rev 0 by First Bud (Pty) Ltd;
- (d) WTG Consulting Engineers (Pty) Ltd for all movement at grade intersection with bituminous surfacing, turning and auxiliary lanes with sufficient drainage facility of the road along A1 road in Capricorn for proposed development as per drawing No. CAPR/JUNC/302 by Sundial Oasis;
- (e) Molphin & Associates Consulting Engineers (Pty) Ltd for a proposed road reserve occupation by 1 No. 200mm diameter sewer pipeline along Mmamashia – Oodi road (B135) in Matebeleng Village as per drawing No. 605 Rev 0 by Milner Park Enterprises (Pty) Ltd;

- (f) Molpin & Associates Consulting Engineers (Pty) Ltd for all movement at grade intersection with bituminous surfacing, turning and auxiliary lanes with sufficient drainage facility of the road along B135 in Matebeleng for the proposed filling station as per drawing No. 605 Rev 1 by Milner Park Enterprises (Pty) Ltd;
- (g) Molpin & Associates Consulting Engineers (Pty) Ltd for all movement at grade intersection with bituminous surfacing, turning and auxiliary lanes with sufficient drainage facility of the road along A14 in Serowe for the proposed filling station as per drawing N0. 601 Rev 1 by Moswela Industries (Pty) Ltd;
- (h) Innovative Ideas (Pty) Ltd for the proposed left-in movement access along A1 road in Bokaa, for the proposed filling station as per drawing No. 01 Rev 02 by Agnes Kgaodi (Grand Peak (Pty) Ltd);
- (i) William Lee Associates (Pty) Ltd for the proposed left-in movement access along A1 road into the proposed filling station, Molongwana Ward in Mmamashia as per drawing No. 601 Rev A by Agnes Kgaodi;
- (j) William Lee Associates (Pty) Ltd for the proposed left-in movement access along A3 road in Maun for the proposed filling station as per drawing No. 601 Rev 2 by Constance Thabologo Mbulawa; and
- (k) Jack Turner (Pty) Ltd for all movement at grade intersection with bituminous surfacing, turning and auxiliary lanes with sufficient drainage facility of the road along A14 road in Paje for the proposed filling station as per drawing No. 2022/06/S300 Rev A2 by Quadramative (Pty) Ltd.
