1. Citation

IN EXERCISE of the powers conferred on the Minister of Finance by section 150 of the Public Procurement Act, the following Regulations are hereby made —

1. These Regulations may be cited as the Public Procurement (Amendment) Regulations, 2023. Citation

2. The Public Procurement Regulations are amended in the Second Schedule by substituting for the Schedule appearing therein, the following new Schedule — Amendment of Second Schedule of Act No. 24 of 2021 (Sub. Leg.)
